138/21 BUSINESS ARISING FROM MINUTES:

The Delegate from Manly Lota asked for an update on Stonehouse. The Treasurer stated that there was nothing more to report from the last meeting and we will receive details of the portfolio later in the month.

139/21 ACTION ITEMS

- 1. The District President has spoken to Leanne Cameron, First Assistant Secretary, Wellbeing Services. She has agreed that there is a delay in DVA response times, and she will give a presentation at a council meeting in early 2022.
- 2. Honorary Memberships will depend on the outcome of the AGM and it will be raised again once the outcomes are known.
- 3. The Senior Vice President gave an update from the District President's meeting last Wednesday where he raised the issue of the funeral notices in the Courier Mail. It was elevated to the State Board for Thursday's discussion where the Interim CEO will work with the marketing team to negotiate a deal with the Courier Mail to bring the price down. The State Board agrees that \$400 is an inappropriate cost for a funeral notice and the Senior Vice President will report back with a response from the marketing team.
- 4. In relation to a definitive statement on the RSL name for a club or sub branch, the District President has spoken to the State President. A statement will be prepared. For those RSLs who have received approval from the dim dark past, their status will continue. For those who have not received approval, there will be a separation. Sherwood-Indooroopilly Sub Branch is an example of that where they have completely separated from the service club and the service club no longer uses the RSL name.
- 5. The State President gave an update on helping Afghan refugees, stating that RSL Qld will support Afghan veterans. There are up to \$10,000 in start-up grants for people transitioning out of Defence to start up a business, which has been unheard of in this organisation before. For the Afghan veterans we are always going to be there and it is important to be there to support those individuals who will give evidence before the Royal Commission. Even those who have issues will still need support and those who don't have issues may even cause issues by being part of this Royal Commission. The Afghan refugees is a national issue and Queensland will support whatever National's decision is in relation to that.
- 6. The Board has yet to sign off on the training days for next year, but a draft programme is that these will occur every second month starting in February. The first one will be on Governance.
- 7. A draft letter has been drawn up to the Assistant Deputy Commissioner inviting a DVA representative to attend a council meeting at least twice a year, in addition to our AGM. The letter has been signed and sent.
- 8. The District President explained that the CEO resigned of her own choice or for personal reasons.
- 9. The SED dispute resolution flow chart for Sub Branches was made available for Delegates to collect at the meeting.
- 10. Steve Monteath to include the email from Dave Cusack in his report.

Further to the State President's final comment, the District President asked that each Sub Branch gives appropriate solemnity to Remembrance Day on Thursday, 11th November.

Steve Monteath was warmly welcomed back to the SED Board as Vice President. Michael Muirhead who has stood down from his role as Secretary at Toowong was also welcomed to the position of Vice President on the Board. With the Board's approval, the District President has approached Matthew Rowe and he has agreed to fill the final Vice President position. He was unable to attend the meeting but was welcomed on behalf of the Board. Each of these roles are interim positions and will be voted on at the next AGM. In the meantime, they were all thanked for their commitment to SED and thanked in advance for their support which is needed on the Board.

A question was raised about selling badges for Remembrance Day. A Sub Branch had approached their shopping centre only to hear that the Anzac Day Commemorative Committee was already selling their merchandise. Rob Skoda explained that Woolworths would be a tenant of the shopping centre and it was necessary to approach the centre management for permission as the agreement would be with the entity that manages the centre and not with the tenant. The centre management should broker any disagreements regarding selling merchandise when both parties have been given the appropriate authority.

The District President stated that SED appears to be at the point where it is about to sign the leases on the Limbless Soldiers' building, the Events on Oxlade complex and Merthyr Bowls. It is hoped to be finalised before the end of the year and the District President made the bold guarantee that there will be a drink for the Council because it will be some relief. The Delegate from Manly Lota asked for how many years the lease would be secured. It was confirmed that it would be for 10 years.

143/21 TREASURER'S REPORT

Manly Lota questioned the reimbursements of \$92,410.97. The Treasurer confirmed that it was for the franking credits, the reimbursements for GST and a fair bit of money has come back on paper, but not in reality. The demolition of Logan was a big expense of \$51,000 and there is a lot of interest in the block.

146/21 GENERAL BUSINESS

1. The District President explained that there is a life membership application going through and that he is reliably informed that both the nominating Sub Branch and SED have reached the position where it is going to be resolved.

147/21 NOTICE OF MOTION

In order for SED to be represented at State Congress in accordance with the State Constitution, the following motion needs to be approved:

Doug Egan is appointed as Delegate for RSL South Eastern District Limited and, in the event that Doug Egan is unable to attend, Judy Alterator will be appointed as Delegate.

Moved: Judy Alterator Seconded: Toowong CARRIED with Manly Lota abstaining

The Delegate from Manly Lota suggested that the motion be split to recognise that there should be just one delegate. The Company Secretary explained that last year and this year there was a request for Sub Branches to hold Special General Meetings where it wasn't declared in the Annual General Meeting minutes that a Delegate had been appointed and, that in the event that

that Delegate was unable to attend, then another name was given for the Delegate. This was necessary in order for Delegates to be registered at State Congress. Only about three Sub Branches followed this ruling, so now there is a scramble to get it right and, because SED finds itself with a Delegate instead of a District President, SED has to follow the same ruling. The wording has been directed by State.

The District President put the issue to the Interim CEO who confirmed that the Company Secretary for State does know what she is doing. The wording has to be very clear and assigns another person in the case that the Delegate is unable to vote. The wording is very descriptive as there can only be one Delegate. There is only an issue if the primary Delegate is unable to attend. In 13b of the Constitution, the By Laws detail that the wording 'alternate delegate' should be avoided as they do not exist in the Constitution. We are trying to make sure that by going into this AGM everyone who attends is unquestionable in their authority to act on behalf of the entity in which they represent. If there is a problem with this motion then the Interim CEO will come back to us. If anyone feels uncomfortable it was suggested that they should be an abstinence.

Rob was invited to say a few words about his immediate targets and objectives within State and Delegates were encouraged to ask questions.
